Dr. Pattee reviewed the extensive construction and costs, which must be incurred in relocating the portable. Director Hassman voiced concern about the cost of installation of the portable originally and to the new location, costs that are unrecoverable and are a consequence of not moving forward on building a new high school.

#### RESOLUTION

WHEREAS, the Iowa legislature will examine public school funding and may consider structural changes to the public school funding formula; and

WHEREAS, the Board has determined that the Iowa legislature should maintain the highest priority to promote and fully invest in Iowa's public schools and not enact any legislation which would divert funds away from public education; and

WHEREAS, the Board believes that public schools provide a strong educational environment for Iowa's children and are an economic engine for our local community and that any structural changes to the funding formula could put this environment at risk by directing resources away from public schools.
