## Item No. 5 – Approval of 2020/21 Allowable Growth for Drop-Out/At-Risk Prevention Application

Mrs. White reviewed the application for modified allowable growth for Drop-Out/ At-Risk prevention for the 2020-21 school year.

Mrs. White provided an overview of the different ways in which the District provides resources and support specifically intended to mitigate the risk some students face of dropping out of school. After discussion, Director Heisterkamp moved and Director Hines seconded the motion that the Cedar Falls Community School District approve the application to the School Budget Review Committee for modified supplemental amount of \$923,881 for the At-Risk and Drop-Out student prevention program. ### Item No. 6 – Approval of Plans, Specifications and Set Public Hearing for 2020 Roofing Projects

Dr. Pattee introduced Darrell Smith, Project Engineer, Terracon Consultants. Mr. Smith provided a review of the District's recommended summer 2020 roof replacement projects. Recommended replacements include Holmes Jr. High sections D, N & S, North Cedar sections S and P, and Cedar Heights section C and kitchen roof. After a short question and answer period, Director Hines moved and Director Orvis seconded the motion that the Cedar Falls Community School District approve the plans, specifications and form of contract and set January 27, 2020 at 5:30 p.m. as the date and time to hold a public hearing for the 2020 summer roofing project. ### Item No. 7 – Approval of Bus Bids

Mrs. Gonnerman reviewed the bids received for the purchase of two transit style passenger buses and two conventional propane buses. The recommendation is to accept the bids from School Bus Sales for all four buses. The purchase of these buses will be funded through the 2020-2021 Physical Plant and Equipment Levy and the Volkswagen mitigation grant. After discussion, Director Orvis moved and Director Hines seconded the motion that the Cedar Falls Community School District Board of Education approve the bids from School Bus Sales, Waterloo, Iowa for two 2021 transit passenger buses in the amount of \$226,688 and two 2021 conventional propane passenger buses for \$206,934. A total cost of \$433,622. Directors voting in favor of the motion: Gruber, Hassman, Heisterkamp, Hines, Leeper, Orvis and Wohlpart. Those voting "no" none. Motion carried.

Mrs. Zeigler reviewed the 2019 Cedar Falls Community School District State-Wide Assessment of Student Progress (ISASP) results. The State of Iowa requires assessments for all students in grades 3<sup>rd</sup> -11<sup>th</sup> in English and Math; Science in grades 5, 8, and 10. Mrs. Zeigler advised ISASP is designed and aligned with the Iowa Core Standards and results should not be compared to previous assessments. Mrs. Zeigler stated that Cedar Falls students continue to out-perform students in the State and looks forward to 2020 growth data.
