WHEREAS, the Iowa legislature will consider an expansion of the state funds available to non-public schools; and

WHEREAS, the Board with support of the Cedar Falls Education Association and the Cedar Falls Education Support Professionals, has determined that the Iowa legislature should continue to prioritize and fully invest in Iowa's public schools. We believe in the following principles:

- Public schools educate 90% of students in Iowa and they are essential for a strong democracy.
- Public schools are open to all students regardless of race, religion, gender, socio- economic status and disability.
- Funding for Iowa's public schools should be the state's first priority and the legislature should ensure adequate funding for the next school year prior to any school choice legislation.
- Public schools are overseen by a publicly elected citizen governing board, are required to report academic results to the general public, have an annual public financial audit, and be transparent with all expenditures and decision-making.
- Taxpayers have a right to know how their funds are being used.

WHEREAS, the Board agrees that parents should have the choice to enroll their child in a private or religious school however, these institutions should have the same academic accountability and transparency as public schools,

WHEREAS, the Board recognizes the state currently provides significant financial support for school choice arid any expansion of that funding should not be at the expense of public schools.

WHEREAS, the Board urges the Iowa Legislature to fully fund public schools in recognition of the essential education provided to the students by the dedicated teachers and staff of the Cedar Falls School District.
