Item No. 5 – Approval of 2023-2024 CFEA Contract

Dr. Talbot reviewed the tentative agreement reached on March 29, 2023 between the District and the Cedar Falls Education Association for a one-year period July 1, 2023 to June 30, 2024. This tentative agreement has been ratified by the Cedar Falls Education Association members. The Bargaining unit is comprised of 467 teachers, librarians, counselors, and instructional coaches.

Economics are as follows:

- Add \$1,800 to each cell in the 2022-2023 Base wage salary schedule
- No Step advancement
- Lane changes for employees that meet the requirements
- The base wage generator for Extra Curricula Athletics and Activities Schedule: \$36,875 The percentage applied to the generator for the following activities assignments shall be:
 - Head Marching Band Percussion Coordinator 4.5%
 - Marching Band: Pit Percussion Coach 1.5%
 - Color Guard Coordinator 6.5%
 - High School Choir Pianist 8.5%
- The base wage generator for the Department Chairs Schedule: \$36,395

Recommendation:

The total salary increases, including lane advancement where applicable, FICA and IPERS is 2.81%. We recommend acceptance of this tentative agreement.

Note: Insurance is an excluded subject of bargaining. The employee contribution to premium for single coverage on the \$750 deductible health insurance plan will increase from \$5/month to \$147/ a month. The total package settlement including, FICA, IPERS and insurance is 3.04%. The total cost of the settlement is \$1,159,774.

Director Hines moved and Director Stutzman seconded the motion to approve the proposed 2023-2024 Cedar Falls Education Association collective bargaining contract as presented. Directors voting in favor of the motion: Coil, Gruber, Hassman, Leeper, Hines, Meyer and Stutzman. Those voting "no" none. Motion carried.

Item No. 6 – Approval of E-Rate: New High School Equipment

Superintendent Pattee reviewed the Federal E-rate program through the direction of the Federal Communications Commission (FCC) for funding of school equipment. It is through a competitive bidding process for equipment for the new high school, such as switches, wireless routers, licenses, trans-receivers, etc. Director Gruber moved and Director Leeper seconded the motion to approve the E-Rate bid from DataVision in the amount of \$765,306.97 as presented: Directors voting in favor of the motion: Coil, Gruber, Hassman, Hines, Leeper, Meyer and Stutzman. Those voting "no" none. Motion carried.

Item No. 7- Approval of the 2023-2024 Proposed Budget for Publication and Set Public Hearing Date

Mrs. Gonnerman presented the 2023-2024 proposed budget to the Board of Education including information on operating fund revenues from local, state, federal sources and required expenditures for these funds. The proposed tax rate for the 2023-2024 school year would be \$15.27920 per thousand dollars of assessed valuation. After discussion, Director Meyer moved and Director Gruber seconded the motion that the Cedar Falls Board of Education direct the secretary to publish the budget estimate and notice of public hearing, as required by law, in the Waterloo/Cedar Falls Courier, and that the public hearing for the 2023-2024 proposed budget be held at 5:30 p.m. on Monday, April 24, 2023 at the City of Cedar Falls City Hall, 220 Clay Street, Cedar Falls, Iowa 50613 as presented. Directors voting in favor of the: Coil, Gruber, Hassman, Hines, Leeper, Meyer and Stutzman. Those voting "no" none. Motion carried.

Item No. 8- Approval of the 2022 -2023 School Year Budget Amendment and Set Public Hearing

Mrs. Gonnerman reviewed the proposed expenditure amendment to the 2022-2023 school year for instructional programs from \$50,838,541 to \$52,830,903 due to reading curriculum and high school equipment. An increase in support services from \$23,061,508 to \$23,249,068, due to increased operational expense. An increase in Non-instructional programs due to supply and food increased costs and an increase in other expenditures from \$61,538,481 to \$66,583,712 due to natatorium construction at new high school. The amendment to the 2022-2023 school year budget will not raise property taxes, but will give the District the legal authority to spend the additional dollars necessary for the additional expenses. After discussion, Director Stutzman moved and Director Meyer seconded the motion that the Cedar Falls Board of Education set 5:30 p.m. Monday, April 24, 2023 at the City of Cedar Falls City Hall, 220 Clay Street, Cedar Falls, Iowa, as the time, date, and place to hold a public hearing to amend the current 2022-2023 school year estimated budget expenditures as presented. Directors voting in favor of the motion: Coil, Gruber, Hassman, Leeper, Hines, Meyer and Stutzman. Those voting "no" none. Motion carried.
