<u>Item No. 7 – Approval of District Facility Committee Recommendation to the Board for Public Input on Bond</u> Referendum

Dr. Pattee reviewed the proposed timelines for community input in regards to district facilities. The timeline was approved by the District Facilities Committee on December 10, 2014. The initial town hall meetings in January will provide an opportunity to present the overall problem the District faces to the community and give community members an opportunity to discuss the problems and provide possible solutions for feedback. The town hall meetings in February will be an opportunity for key findings to be presented from the first set of town hall meetings and the opportunity for community members to offer input to the needs for the High School and Elementary schools. The third set of town hall meetings in March will be for distribution of feedback from February town hall meetings, presentation of initial design concepts for the high school and elementary schools and give community members an opportunity to offer input on these designs for potential solutions. The fourth town hall meetings in April will be for final design concept presentation for potential high school and elementary schools based on the solutions discussed in previous town hall meetings and an opportunity for community member questions and input on the design concept plan.

The January and February public input meetings will be held at AEA 267 on January 21st and 22nd, 2015 and February 18th and 19th, 2015. Board members discussed various topics associated with the meetings including dates and locations of the meetings, communication to the public of these meetings, meeting format, current district information and challenges, as well as community feedback. Discussion also was held concerning the tentative bond vote referendum date of June 30, 2015. Director Shaw expressed concern with that date. After extensive discussion Director Kenyon moved and Director Lantz seconded the motion to accept the recommendation of the District Facility Committee for the time lines for public input on the bond referendum.
