<b>What is the overall <u>deductible</u>?</b>	In-Network: <b>\$250</b> person/ <b>\$500</b> family per calendar year. Out-of-Network: <b>\$500</b> person/ <b>\$1,000</b> family per calendar year.	Generally, you must pay all the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your <u>deductible</u>?</b>	Yes. Well-child care, <u>preventive care</u> , in- <u>network</u> independent labs/maternity care/prosthetic limbs, ambulance, routine vision exam, in- <u>network</u> mental health substance abuse services for DME and <u>home health care</u> and services subject to health and drug card <u>copayments</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. <b>What is the <u>out-of-pocket limit</u> for this <u>plan</u>?</b>	Health In-Network: <b>\$1,000</b> person/ <b>\$2,000</b> family per calendar year. Health Out-Of-Network: <b>\$2,000</b> person/ <b>\$4,000</b> family per calendar year. Drug Card: <b>\$1,000</b> person/ <b>\$2,000</b> family per calendar year. The In-Network health and drug card <u>out-of-pocket</u> maximum amounts accumulate separately.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.

You will pay the most if you use an out-of- <u>network provider</u> , and you might receive a bill from a <u>provider</u> for the difference between the <u>provider's</u> charge and what your <u>plan</u> pays ( <u>balance billing</u> ). Be aware, your <u>network provider</u> might use an out-of- <u>network provider</u> for some services (such as lab work). Check with your <u>provider</u> before you get services.
