In order for the ballot to be counted, the ballot must be received by the AEA Board Secretary by the end of the normal business day on November 28, 2025, or be clearly postmarked by an officially authorized postal service not later than November 29, 2025, and received by the AEA Board Secretary not later than noon on the first Monday following November 30, 2025.

Board members will be sworn in on December 3, 2025, at the regularly scheduled Central Rivers AEA Board of Directors meeting.

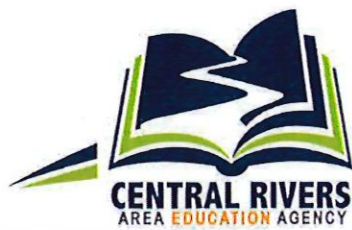

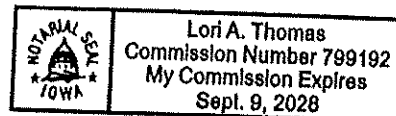

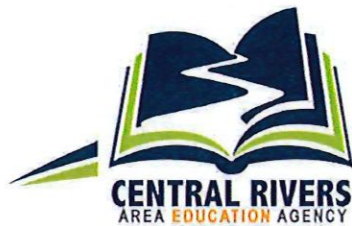
