As shown on the June 30, 2019 Treasurer's Reconciliation Report for the Cedar Falls Community School District, balances were as follows:

Depository account balances at Farmers State Bank totaled \$6,787,480.07, spread over five different accounts. Our various investment accounts, held by Lincoln Savings Bank, Collins Community Credit Union and Farmers State Bank total \$17,782,648.37 for a total Treasurer's balance effective June 30, 2019 of \$24,570.128.44.

By comparison, the District Secretary's Fund balances total \$24,020,025.05, combined with the difference for Outstanding Checks, RevTrak Deposits, Federal & State Taxes and Deposits in Transit in the amount of \$550,103.39, total \$24,570,128.44 as of the same date.

I am happy to report a balanced reconciled report totaling \$24,570,128.44.
