Dr. Pattee reviewed the history of the District's facilities/roof area and the 10 year PPEL construction plan. Dr. Pattee reported a total of three bids were received for the three roofing projects and it is the recommendation of the Administration and Terracon consultant to approve the low quote from Black Hawk Roof Company, Cedar Falls, Iowa in the amount of \$274,535. This project will be funded through the 2020-2021 Physical Plant and Equipment Levy. <u>Item No. 5 – Approval of North Cedar Playground Project Bid</u>

Dr. Pattee reported a total of seven bids were received for the North Cedar grading improvements and it is the recommendation of the Administration and Fehr Graham to approve the low quote from Benton's Sand & Gravel, Inc., Cedar Falls, Iowa in the amount of \$252,215.95. Dr. Pattee stated this bid came in quite a bit lower than the other bids and thanked Benton's Sand and Gravel for their generosity and support to the District. After discussion, Director Gruber moved and Director Leeper seconded the motion that the Cedar Falls Community School District Board of Education approve the North Cedar Elementary grading improvement project bid from Benton's Sand & Gravel, Inc. of Cedar Falls in the amount of \$252,215.95.
