What is the overall <u>deductible</u>?	In-Network: \$750 person/ \$1,500 family per calendar year. Out-of-Network: \$1,500 person/ \$3,000 family per calendar year.	Generally, you must pay all the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. Well-child care, <u>preventive care</u> , in-network independent labs/maternity care/prosthetic limbs, ambulance, routine vision exam, in-network mental health substance abuse services for DME and <u>home health care</u> and services subject to health and drug card <u>copayments</u> . The In-Network health and drug card <u>out-of-pocket</u> maximum amounts accumulate separately.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. Does this plan provide Minimum Essential Coverage? Yes
