



28E Agreement
Between

Cedar Falls Community School District (CF CAPS)
and
Waterloo Schools/Waterloo Career Center (WCC)

Pursuant to the provisions of Chapter 28E and Section 280.15 of the Code of Iowa, this agreement is entered into between the Cedar Falls Community School District and Waterloo Schools.

In consideration of the mutual obligations expressed below, the parties agree as follows:

Course Enrollment Slots

- The Cedar Falls Community School District agrees to provide Center for Advanced Professional Studies (CF CAPS) classroom spaces for assigned students in grades 11-12 from the Waterloo Schools as available.
- The Waterloo Schools agrees to provide Waterloo Career Center classroom spaces for assigned students in grades 11-12 from the Cedar Falls Community School District as available.

Tuition

- Tuition for Cedar Falls Schools students being served at the Waterloo Career Center will be charged at the rate of \$450 per student per semester per block.
- Tuition for Waterloo Schools students being served in the Cedar Falls CAPS program will be charged tuition at the rate of \$450 per student per semester per course.
- Fees will be charged ONLY for students in excess of the in/out balance.

Transportation

- The Cedar Falls Community School District will not be responsible for transporting students from Waterloo to the Cedar Falls CAPS program but may transport students to the Waterloo Career Center.
- The Waterloo Schools will not be responsible for transporting students from Cedar Falls to the Waterloo Career Center but may transport students to the CAPS program in Cedar Falls.

Supplies and Materials

- The Waterloo Schools and Cedar Falls Community School District will be responsible for providing the appropriate curricular materials, supplies and programmatic needs for

students attending the program from the partner school (i.e. uniforms, technology, software applications, other materials)

Program Promotion

Waterloo Schools and Cedar Falls Community School District agree to the following promotional opportunities in each respective district:

- Parent-Teacher Conferences
- 8th grade scheduling meetings
- 9th grade/New student orientation
- Any additional meetings as agreed upon by both Districts

Policies and Procedures

- Students attending the CF CAPS or Waterloo Career Center will follow the rules, regulations and desired outcomes of the shared school partner while attending the program.
- Attendance and Grading Information: Each District shall provide the home district with appropriate information regarding the attendance and any grades earned at the CF CAPS or Waterloo Career Center.
- In cases of changes to the school day or school calendar, the CF and Waterloo administration will make every effort to notify the partner school in advance of the change, recognizing that changes due to inclement weather may come with short notice.

This agreement shall be in effect for the 2020-2021 school year. Extension of this agreement shall be by written mutual consent of both parties and will be reviewed by May 15 of every year.
