Item No. 1 – Closed Session of the Board of Education Under Iowa Code Section 21.5(1)(e)

Director Leeper moved and Director Brown seconded the motion to move that the Cedar Falls Board of Education enter into closed session to discuss whether to conduct a hearing or to conduct hearings to suspend or expel a student, unless an open session is requested by the student or a parent or guardian of the student, if the student is a minor as provided under the 2011 Code of Iowa 21.5(1)(e). 3. Student A must make satisfactory academic progress while enrolled at BIC.
4. Student A must maintain good attendance and have no disciplinary incidents while enrolled at BIC.
5. Student A must complete a substance abuse evaluation and follow through with any recommendations as a result of the evaluation.
6. Student A must meet with Juvenile Corrections Services Officer, if assigned, and complete any required recommendations.
7. Student A must not participate, or attend, any school related activities (both home and away) during the period of suspension.
8. Student A must stay away from all school buildings and grounds during the period of suspension.
9. Student A will be required to appear before the Board of Education prior to Student A’s readmission for regular attendance to Holmes Junior High School.
