Item No. 5 – Informational Report: 10-Year PPEL Update

Dr. Pattee reviewed the 10-year Physical Plant and Equipment Levy (PPEL) plan and the process utilized for selection of projects. The weighted system is based on a ten-point scale with focus on three areas, educational improvements, safety and efficiency. A list of short term and long term projects were discussed.

Item No. 6 - Approval of Plans, Specifications, and Set Public Hearing for the North Cedar Elementary Playground Project

Mrs. Gonnerman introduced Jon Biederman from Fehr-Graham Engineering and Environmental. Mr. Biederman reviewed the specifications for the North Cedar Elementary playground project. After discussion, Director Gruber moved and Director Heisterkamp seconded the motion that the Cedar Falls Community School District Board of Education approve the plans, specifications and form of contract and set January 27, 2020 at 5:30 p.m. as the date and time to hold a public hearing for the 2020 North Cedar playground project. <u>Item No. 7 – Update on High School Planning</u>

Dr. Pattee introduced Mr. Brian Sanderman from InVision Architecture. Mr. Sanderman provided an update on the new high school and reviewed the process to gather information with staff, community and students regarding the planning. He advised they met with many community group meetings, gathered information and input from students, teachers, community members, parents and special consultants in many areas. Moving forward with design.

<u>Item No. 8 – Approval of 2020-2021 SBRC for Special Education Administrative Cost – River Hills</u>

Mrs. Gonnerman reviewed the School Budget Review Committee (SBRC) application request for additional allowable growth for special education administrative costs associated with the River Hills Consortium program for the 2020-21 school year. The total cost of the consortium program administrative salary expense is divided equally amongst member school districts based on the number of students enrolled. The total District request is for \$19,782.50. This request, if approved by the SBRC, would allow the District to include \$19,782.50 in special education expense for the operation of the River Hill consortium program. Director Hines moved and Director Gruber seconded the motion to approve the request to the School Budget Review Committee in the amount of \$19,782.50 for special education administrative costs associated with River Hills Consortium program for the 2020-21 school year. Directors voting in favor of the motion: Gruber, Hassman, Heisterkamp, Hines, Leeper, Orvis, and Wohlpart. Those voting "no" none. Motion carried.

Item No. 9 - Approval of 2020-2021 SBRC Administrative Costs - Lied Center

Mrs. Gonnerman reviewed the School Budget Review Committee (SBRC) application request for additional allowable growth for special education administrative costs associated with the Lied Center (Bremwood Consortium) in Waverly. The total cost of the consortium program administrative salary expense is divided equally amongst member school districts based on the number of students enrolled. The total District request is for \$12,448.25. After discussion, Director Wohlpart moved and Director Leeper seconded the motion to approve the application to the School Budget Review Committee in the amount of \$12,448.25 for special education administrative costs associated with Lied Center Consortium program for the 2020-2021 school year as presented. Directors voting in favor of the motion: Gruber, Hassman, Heisterkamp, Hines, Leeper, and Wohlpart. Director Orvis recused himself. Those voting "no" none. Motion carried.

Item No. 10 – Approval of SBRC for Modified Allowable Growth

Mrs. Gonnerman reviewed the application to the School Budget Review Committee (SBRC) for additional allowable growth for increased enrollment, open enrollment out and English Language Learners (ELL) Beyond 5 years' allowable costs for the 2019-2020 school year. Mrs. Gonnerman reported the District is requesting for a maximum allowable growth request to the SBRC in the amount of \$944,761.60. This includes \$920,544 for increased enrollment and \$24,217.60 for ELL Beyond 5 year. Director Orvis moved and Director Hines seconded the motion the Cedar Falls Community School District approve the application to the School Budget Review Committee in the amount of \$920,544 for modified allowable growth due to increasing student enrollment and increasing enrollment out students. In addition, \$24,217.60 for ELL proficient instruction for students in the program beyond five years for the 2019-2020 school year. Directors voting in favor of the motion: Gruber, Hassman, Heisterkamp, Hines, Leeper, Orvis, and Wohlpart. Those voting "no" none. Motion carried.
