- 3. Student A must complete a substance abuse screening and follow through with any recommendations made for follow up treatment.
- 4. Student A must meet with Juvenile Corrections Services Officer and complete any required recommendations.
- 5. Student A must make satisfactory academic progress while enrolled at the BIC.
- 6. Student A will be required to appear before the Board of Education prior to Student A's readmission for regular attendance at Cedar Falls Schools.
- 7. Student A must maintain good attendance and have no disciplinary incidents while enrolled at the BIC.
- 8. Student A must stay away from all school buildings and grounds during the period of suspension/excludion.
- 9. Student A must not participate, or attend, any school related activities (both home and away) until fully reinstated in school.
