Item No. 6 – Approval of Hansen Phase II Project Bids

Mr. Nefzger introduced Mr. Daniel Channer from Struxture Architecture. Mr. Channer reviewed bids received for the Hansen Phase II addition and remodeling project. The District received a total of five bids for the project. Mr. Channer recommended to the Board to accept the low base bid from Cardinal Construction, Waterloo, Iowa in the amount of \$8,720,000. Mr. Channer also recommended acceptance of Alternates 1, 2b, 3, 4, 5, 6 and 7. The total cost of the project including the Alternates is \$9,364,040. Mr. Nefzger reported that Alternate number 6 in the amount of \$112,300 would be funded by the Physical Plant and Equipment Levy. After review of the bids Director Kenyon moved and Director Williams seconded the motion to approve the bid from Cardinal Construction, Waterloo, Iowa for the Hansen Phase II addition and remodeling project including Alternates 1, 2b, 3, 4, 5, 6 and 7 at a total cost of \$9,364,040. With the exception of Alternate 6 the project will be paid for with Secure a Vision for Education or (Local Option Sales Tax) funds. Directors voting in favor of the motion Senchina, Brown, Leeper, Coil, Kenyon, Lantz, and Williams. Those voting "no" none. Motion carried.

Item No. 7 – Approval of Substantial Completion of High School Gym Floor Project

Mr. Nefzger reviewed the substantial completion of the High School gym floor project. Mr. Nefzger reported the original project budget was \$265,862 and the actual final cost for the project is \$299,075 and recommended final acceptance of the project. The additional expenses were due to additional work required upon removal of the original gym floor. Director Brown motioned and Director Leeper seconded the motion that the Cedar Falls Community School District Board of Education accept, as complete the High School gym floor project for all claims for materials furnished, labor performed and service on this contract must be filed within the next 30 days. Directors voting in favor of the motion Senchina, Brown, Leeper, Coil, Kenyon, Lantz, and Williams. Those voting "no" none. Motion carried.

Item No. 8 – 2011-2012 Mobility Report

Mr. Wells reviewed the student mobility report for the Cedar Falls Community School District for the 2011-2012 school year. In summary, the report stated there were a total of 418 elementary transfers, 154 junior high transfers, and 184 senior high transfers, and total alternative school transfers of 80, for a total of 836 transfers. This includes transfers in and out of the school district. Other data reviewed included where transfer students came from and went to, as well as historical data of transfer students for the Cedar Falls Community Schools from 2002/03 school year to the present.
