

**2020-2021 Cedar Valley CAPS Fall Semester**  
28E Agreement  
between  
**Cedar Falls Community School District (CF CAPS)**  
and  
**Cedar Valley Catholic Schools (Columbus CAPS)**

Pursuant to the provisions of Chapter 28E and Section 280.15 of the Code of Iowa, this agreement is entered into between the Cedar Falls Community School District and Cedar Valley Catholic Schools.

**In consideration of the mutual obligations expressed below, the parties agree as follows:**

- The Cedar Falls Community School District (CFCSD) agrees to provide course frameworks, training, and support for the Columbus Center for Advanced Professional Studies (Columbus CAPS) program. The services listed below will be provided throughout the fall semester of the Cedar Valley Catholic Schools' 2020-2021 school calendar year.
- The Columbus CAPS program will be responsible for providing the appropriate curricular materials, supplies and needs for their staff and associates.
- Cedar Valley Catholic Schools agrees to pay CFCSD for the support services provided by Cedar Valley CAPS (CV CAPS) staff in the sum of \$7000 per semester per instructor; not to exceed \$21,000 in a given school year.
- Cedar Valley Catholic Schools has one instructor with at least one course in the FALL with a total invoice for services of \$7,000.

**Support services provided by CV CAPS program and staff**

- Instructor Training
  - Professional Development Opportunities
  - Regular updates and reminders for instructors
  - Regular check-ins with area CV CAPS instructors
  - Development of business partners: projects, experiences, mentors, etc
  - Access to all CV CAPS affiliate programs' projects and professional networks
  - Coordination between CV CAPS affiliates in programming and project execution
  - Regular on-site program visits
  - Monthly administration meetings
  - Access to CV CAPS curriculum and program schedule
  - Access to the CAPS National Network programs and curriculum
  - Waived CAPS Network fee
  - Advocacy for profession-based learning at a local and state level

- CV CAPS is invested in supporting a successful Columbus CAPS program and will provide the services to do so at the level listed above. However, CFCSD is not responsible for the full implementation and support of the Columbus CAPS program. If Columbus CAPS requests support from CV CAPS staff at a higher level than listed above, another 28E agreement will need to be agreed upon and developed based on the time commitment of the request.
  - The invoice for fall semester services will be provided no later than February 15, 2021 and the final invoice for spring semester services no later than June 30, 2021.
  - In the event a course does not run during a given semester there will be no invoice for those services.

This agreement shall be in effect from August 15, 2020 to February 1st, 2021. Extension of this agreement shall be by written mutual consent of both parties and will be reviewed by May 15, 2021.
