# Summer Driver Education Session 2020 - Information and Registration Cedar Falls Community Schools

The Goulden Rule Driving School L.L.C. in affiliation and contract with the Cedar Falls Community Schools will be providing Driver Education to Cedar Falls students. Students must be at least 14 years of age and possess a valid driver permit by the first day of class. We will have a target number of 30 students per session and there will be 3 sessions based on registration. We reserve the right to accept student on a first come first serve basis.

#### **Projected Dates and Times**

#### (Please remember these dates may change in the event of snow days)

- May 19<sup>th</sup>, 21<sup>st</sup>, 26<sup>th</sup>, 28th– First class for all sessions.. Classroom instruction will be held from 6:00 -8:00 PM at Holmes Junior High. (Rooms to be announced). Driving schedules will be assigned and classroom instruction will begin.
- Wednesday June 3rd Regular two-hour classroom sessions will begin. Then, class will be daily (Monday-Friday). <u>Classroom sessions are scheduled to be completed by June 18th but the driving may last until June 22nd.</u>
- The State of Iowa mandates six hours of behind the wheel instruction and 30 hours of classroom instruction. (32 hours of instruction will be provided). Behind the wheel instruction will be arranged the first day of class. Classroom and driving hours must be consecutive.
- Attendance Policy: One miss no charge. Second miss is \$25.00 per hours that needs to be made up. Third miss student will be dropped from the course.
- The cost of the course is \$370.00. A \$185.00 deposit is required with registration and the balance of the tuition will be collected the first day of classroom instruction. The deposit is refundable if notified 10 days before classroom instruction begins. No refunds will be given after the first day of class. Make checks payable to the Goulden Rule Driving School L.L.C. Certificates of completion will not be submitted to the DOT until all financial obligations have been fulfilled.
- Students on the free or reduced lunch program may have all or part of their tuition paid for by the Cedar Falls Community Schools. (Contact Jay Goulden for details (319-277-3832)
- Any student failing to show up for their behind the wheel instruction without prior notification will be subject to a \$50.00 fee.

### Operating Agreement for the Goulden Rule Driving <u>School, L.L.C.</u>

It is the intent of the Goulden Rule Driving School and affiliates of the company to provide instruction and experience to students of all ages in driver education. Instructors of the Goulden Rule Driving School (GRDS) are certified teachers in the state of Iowa. The format of the school may vary depending on the time of year, (summer or during the school year) however, instructional content will be the same.

## Iowa State requirements will be met or exceeded:

- 1. Length of the day may not exceed 180 minutes.
- 2. Number of classroom hours will be a minimum of 30 hours (34 will be offered).
- 3. Students will receive 240 minutes of substance abuse education.
- 4. Students will receive a minimum of 20 minutes of railroad crossing safety.
- 5. Students will be provided instruction relating to organ donation under the Uniform Anatomical Gift Act.
- 6. Two or more students will be scheduled for all behind the wheel instruction.
- 7. 30 minutes per session, 60 minutes per day is the maximum a student may drive in one day.
- 8. The minimum number of times a student will drive in a duel control automobile during the entire course without simulation or range is 12.
- 9. A maximum of 360 minutes of range instruction may be substituted for behind the wheel instruction.
- 10. All driver education instructors, with the exception of behind the wheel instructors, must hold a valid Iowa secondary teaching license and the Driver Education endorsement.

It is our intent that all students will complete the course at program's end. However, students with excessive absences, tardies, or deficient driving abilities, as judged by the instructor, will be dismissed from the program or be required to obtain more driving experience before being issued a certificate of completion. Additional driving experience may be obtained with the instructor or other persons meeting state requirements as at discretion of the instructor.

Upon completion of the course, students will be awarded a certificate of completion, which will allow them eligibility for intermediate driver's license under the Graduated License System of the state of Iowa. All other Graduated License requirements must be met. (See graduated License information from the Department of Transportation)
