Item No. 3 – Approval of 2015-2016 CFEA Contract

Dr. Talbot, Director of Human Resources reviewed the tentative agreement between the District and the Cedar Falls Education Association for the 2015-2016 contract year. The agreement will cover a one year period on economics from July 1, 2015 to June 30, 2016 and a two year agreement on language from July 1, 2015 to June 30, 2017 was reached on June 3, 2015. This follows a one year agreement, which expires on June 30, 2015. This tentative agreement has been ratified by the Cedar Falls Education Association members.

Economics:

- \$585 addition to the 2014-2015 base salary
- Step advancement
- Add electronic media production to the supplemental salary schedule
- The District will pay the increase in individual health, vision and dental insurance premiums

Language:

Personal Leave – Allow maximum accrual of up to four(4) days, prohibit leave on specified days while increasing
flexibility regarding leave requests on days preceding holidays subject to administrative guidelines.

The total package settlement is an increase of 3.32%. Director Brown moved and Director Kenyon seconded the motion to approve the proposed 2015-2016 contract between the Cedar Falls Education Association and the Cedar Falls Community School District. Directors voting in favor of the motion: Brown, Coil, Williams, Leeper, Shaw and Lantz. Those voting "no" none. Motion carried.

Item No. 4 – Approval of 2015-2016 Teamsters Contract

Dr. Talbot reported a tentative agreement was reached between the District and Teamsters Local 138 on May 28, 2015 on a contract to cover a one year period July 1, 2015-June 30 2016 on economic items. The second year of the 2014-16 agreement on language items will take effect July1, 2015. This follows a one year agreement for 2014-2015, which expires on June 30, 2015. This tentative agreement has been ratified by Teamster's members.

Economic Items

- Employee paid monthly health insurance single premium to increase from \$1.00 to \$5.00.
- Increase hourly wage rate for current and new employees by \$0.60/hour.

There is a total package increase of 3.57%. Director Shaw moved and Director Kenyon seconded the motion to approve the proposed 2015-2016 contract between the Teamsters Local 138 and the Cedar Falls Community School District. Directors voting in favor of the motion: Brown, Coil, Kenyon, Williams, Leeper, Shaw. Those voting "no" none. Motion carried.

<u>Item No. 5 – Approval of 2015-2016 Supervisors, Managers, Coordinators, Transportation, District Media Technicians, 12-month Clerical Salary and Benefit Adjustment Contract</u>

Dr. Talbot reviewed the wage and salary adjustments for non-bargaining employee groups for the 2015-2016 school year. The recommendation is for a 3.30% total percentage increase in salary and benefits for 12-month clerical, supervisors, managers, coordinators, technicians, bus mechanics and bus drivers. This includes an employee monthly contribution to single health insurance premium increase from \$1.00 to \$5.00. Director Leeper moved and Director Brown seconded the motion to approve the recommendation as presented. Directors voting in favor of the motion: Coil, Brown, Leeper, Williams, Kenyon and Shaw. Those voting "no" none. Motion carried.

Item No. 6- Approval of 2015-2016Administrator Team Salary and Benefit Package

Dr. Pattee reviewed his recommendations for administrative team salary and benefit compensation for the 2015-2016 school year. It is Dr. Pattee's recommendation for a total package increase of 3.30% in salary and benefits for all administrators, except the Superintendent throughout the District. Director Shaw moved and Director Kenyon seconded the motion to approve a 3.30% increase in administrator salary and benefit package for the 2015-2016 school year. Directors voting in favor of the motion: Coil, Brown, Leeper, Williams, Kenyon and Shaw. Those voting "no" none. Motion carried.
